Terms and Conditions

Competition Period	12.01am (AEST) on 15/07/2026 to 11.59pm (AEST) on 28/07/2026.
Who can enter?	Only Australian residents who: (a) are aged 18 or over; and (b) become a new member of the Cadbury Club (Member) during the Competition Period. Membership of the Cadbury Club (and, consequently, participation in this competition) is subject to the terms and conditions which apply to the Cadbury Club available at https://club.cadbury.com.au, as amended from time to time.
Who can't enter?	Directors, officers, management, employees and contractors (and their immediate families) of: (a) the Promoter; and (b) the agencies, companies or participating premises associated with this competition.
