Who can enter?	Only Australian residents who: (a) are aged 18 or over; and (b) are an existing member of the Cadbury Club (i.e. already opted-in to receive marketing materials from the Promoter). Membership of the Cadbury Club (and, consequently, participation in this competition) is subject to the terms and conditions which apply to the Cadbury Club available at https://club.cadbury.com.au, as amended from time to time.
Who can't enter?
