

Cadbury Club New & Existing Member Promotion (September 2026) Terms and Conditions

Competition Period	12.01am (AEST) on 15/09/2026 to 11.59pm (AEST) on 24/09/2026.
Who can enter?	Only Australian residents who: (a) are aged 18 or over; (b) and either: (i) become a new member of the Cadbury Club (and opt-in to receive marketing materials from the Promoter) during the Competition Period (New Member); or (ii) are an existing member of the Cadbury Club (i.e. already opted-in to receive marketing materials from the Promoter) (Existing Member). Membership of the Cadbury Club (and, consequently, participation in this competition) is subject to the terms and conditions which apply to the Cadbury Club available at https://club.cadbury.com.au, as amended from time to time.
Who can't enter?	Directors, officers, management, employees and contractors (and their immediate families) of: (a) the Promoter; and (b) the agencies, companies or participating premises associated with this competition. Entry instructions	There are 2 ways to enter this Competition. You can only enter via 1 of the 2 entry methods as set out below. <u>New Member Entry Method</u> (a) To enter, you must, during the Competition Period: - either: (i) click on the Promoter's advertising for the Cadbury Club on advertising/sponsored posts on Facebook or Instagram; or (ii) scan the QR code on advertising materials where available for this promotion; or (iii) visit the Website directly; and Follow the prompts to sign up to become a New Member of the Cadbury Club, including providing all requested information and opting in to receive marketing materials by the Promoter. 	There is a limit of one prize per household (based on residential address).
